

Incentives/Sanctions Matrix: Noncompliance Behaviors and Responses

Nebraska Parole has implemented a Behavior Management System (BMS) sanctioning process. The Incentives/Sanctions Matrix was programmed into the system as part of the implementation of BMS. Since revocation is a Board of Parole proceeding, and not a sanction, it is not listed as a response to noncompliance. Abscond is also not listed; however, it is the highest level of noncompliance which requires a Review of Parole hearing for Nebraska clients and mandatory retaking for Interstate Compact offenders. Custodial sanctions have been implemented in Nebraska Parole. This is the highest level of sanction short of revocation and Interstate Compact offenders are subject to custodial sanctions the same as Nebraska clients. Custodial sanctions for parole clients may be imposed up to 30 days at a time, not to exceed a total of 60 days. It is not a requirement that any or all custodial sanction days be imposed prior to making a determination that violations rise to the level of behavior requiring retaking; this is consistent with Nebraska's process for Nebraska parole clients. The Matrix provides incentives/sanctions to address levels of severity; however, depending on the violations, the behavior may rise to the level of revocation.
