| I. | Welcome | Deputy Director Berry opened the meeting and thanked everyone for attending. He acknowledged Commissioner Tischner's absence, made opening remarks, and extended best wishes. Attendance was taken, then Deputy Berry allowed everyone in the meeting to introduce themselves and their role on the Council. |
| II. | ICAOS Compliance | DCA Elizabeth Powell gave a brief overview acknowledging the work of the Interstate Compact and highlighted the importance of cross collaboration amongst all partners in the meeting. She shared improved results and impact of collaboration and compliance. |
| III. | Interstate Transfers and DC Superior Court | DCA Powell punctuated the purpose of the Council and the Council's combined vision of keeping the city safe. Judge Josey-Herring stressed the importance of having proactive release and housing plans and recognizing the time colleagues in other states need to investigate cases before transfers take place. Attorney Advisor Simmonds thanked the Court for its collaboration and informed the Council of Senior Advisor Redwood transition to replace her on the Council. Judge Josey-Herring suggested that a fact sheet be developed and circulated to the different judges to inform them of the interstate transfer process and its timelines to encourage the Court's continued collaboration. Senior Advisor Simmonds and DCA Elizabeth Powell informed her there were already some written communications sent to the court which provided answers to some frequently asked questions, as well as a bench card that explained the interstate process.
