**Standard Conditions of Adult Probation - Attachment A**  
**Special Conditions of Probation for Internet Access and Supervision**  
**Pursuant to *N.J.S.A. 2C:45-1***

**Instructions:** As reflected on the Judgment of Conviction (“JOC”) or condition of supervision under an Interstate Compact for Adult Offender Supervision (“ICAOS”) incoming transfer case, check the box below to indicate that Internet restrictions have been ordered by a court of competent jurisdiction as a condition or special condition of supervision. Attach the completed form to the probationer’s signed Standard Conditions of Probation.

Probation must advise probationers with imposed Internet restrictions that they are required to pay the monthly cost of Internet monitoring pursuant to *N.J.S.A. 2C:45-1*.

Probation must also advise probationers with conditions imposed as reflected on a JOC from a New Jersey court that in accordance with *N.J.S.A. 2C:45-2b*, upon application to the Court, the probationer, the Probation Division, or the court on its own motion, may seek to modify these conditions or add further conditions as authorized by *N.J.S.A. 2C:45-1*. For ICAOS cases, Interstate Commission Rule 4.103 (Conditions of Supervision) and Rule 4.103-1 (Force and Effect of Conditions Imposed by a Receiving State) permit the receiving state (New Jersey) to impose additional conditions on an offender/probationer transferred under the Compact if that condition would have been imposed on the offender/probationer if the sentence had been imposed in the receiving state.

- A.** I have been granted limited use of a non-Apple manufactured computer and/or electronic device that permits access to the Internet as reflected on my Judgment of Conviction (“JOC”) or conditions of supervision under the Interstate Compact for Adult Offender Supervision (“ICAOS”). I understand that I am subject to the following restrictions and conditions concerning my use:
1. I am prohibited from possessing or using any data encryption techniques and/or software programs that conceal, mask, alter, eliminate and/or destroy information and/or data from a computer and/or electronic device;
  2. I am required to install on the computer and/or electronic device, or permit the installation, at my expense, of one or more hardware or software system(s) to monitor my computer and/or device use if such hardware or software system(s) is (are) determined to be necessary for supervision by Probation;
  3. I am required to permit the monitoring of my computer and/or electronic device activity by a probation officer and/or computer/device specialist through the use of electronic means;
  4. I am subject to periodic unannounced examinations of the computer and/or electronic device by a probation officer or designated computer/device specialist, including the retrieval and copying of all data from the computer and/or electronic device and any internal or external peripherals and removal of such equipment to conduct a more thorough inspection;

5. I am prohibited from accessing or using a computer and/or electronic device, Internet-capable device, or similar electronic device to access child pornography or to communicate with any individual or group for the purposes of promoting sexual relations with, among, or between children.

For the purpose of this special condition, child pornographic-oriented material means:

any picture, photograph, negative, film, movie, videotape, Blu-ray, DVD, CD, CD-ROM, streaming video, video game, computer generated or virtual image or other representation, publication, sound recording or live performance, that contains a description or depiction of actual or simulated acts such as, but not limited to, sexual intercourse, oral sex, anal sex, masturbation, bestiality, sadism and/or masochism with, among, or between children

**In addition:**

I am aware that the use or personal possession of any Apple device(s) is strictly prohibited during my term of supervision. If discovered by Probation, use or personal possession of any Apple devices shall be considered by Probation as a violation of my conditions of supervision, and this violation will be the basis of a Violation of Probation being filed against me.

I am aware that Probation maintains a “zero-tolerance” policy with regard to court-ordered restrictions for Internet access and use. Any discovery by Probation of my impermissible Internet or Internet-capable device access or use shall be considered by Probation as a violation of my conditions of supervision, and this violation will be the basis of a Violation of Probation being filed against me.

If use of a computer and/or electronic device is permitted under my JOC or conditions of supervision under ICAOS, I must notify my probation officer prior to purchasing, possessing or utilizing any computer and/or device that permits access to the Internet. I must provide my probation officer with the serial number, brand, model and description of any and all electronic devices with Internet or storage capability that I buy, use, or have access to. I am aware that the failure to identify any electronic device with Internet or storage capability that may be used or accessed by me can be the basis of a Violation of Probation being filed against me.
