Dear National Office,

In an effort to prevent the spread of COVID-19, the Nevada Division of Parole and Probation has taken proactive steps in our eight statewide offices. Effective March 16, 2020, our offices will be temporarily postponing in-person offender reporting, applying to both our local and Interstate Compact offenders. Current Interstate Compact offenders will be directed to make telephonic contact with the Officer of the Day or their assigned officer within our offices. Offenders transferred to Nevada or granted Reporting Instructions after March 16, 2020, will be directed to report telephonically. Our field officers will continue to conduct field operations and will substitute field contacts for office contacts during this time.

During this time, our Compact Office will not process any discretionary transfer requests for either new or existing offenders currently under supervision. Only mandatory transfer requests for offenders sentenced on or after Friday, March 13, 2020, will be processed. This practice will continue until further notice.

Should the Nevada Division of Parole and Probation take further steps to prevent the spread of COVID-19, the Compact Office will re-evaluate our processes and provide further updates.

Attached in Appendix A is a list of contact information and our Compact Office Staff that would be considered in command if the situation requires our physical office to close. Access to ICOTS, email, and voicemail will remain intact should our physical offices close.
