Call to Order

Chair A. Vorachek (ND) called the meeting to order at 2:55 pm ET. Eleven out of 11 commissioners were in attendance, a quorum was established.

Approval of Agenda and Minutes

Commissioner K. Ransom (OH) moved to approve the meeting agenda. Commissioner T. Hudrlik (MN) seconded. Agenda approved as presented.

Commissioner S. Kreamer (IA) moved to approve the minutes from the April 11, 2023, meeting. Commissioner S. Reinhardt-Stewart (NE) seconded. Minutes approved as drafted.

Discussion

2023 Proposed Rule Amendment: Chair A. Vorachek (ND) opened the floor to discuss the rule amendment to 5.108. Commissioner M. Hudson (IN) spoke in favor of the rule and invited region members to provide their remarks.

Commissioner K. Ransom (OH) shared her concerns with the rule change and Ohio's ability hold supervised individuals should the rule pass stating that the change creates too much flexibility and public safety concerns.

The region discussed the rule proposal.
